



## **Refer-A-Wildcat Program Terms and Conditions:**

The following terms and conditions outline the rules and regulations for the Refer-A-Wildcat program (referred to as "the Program") offered by Abilene Christian University (referred to as "the School"). By participating in the Program, you agree to comply with these terms and conditions.

### **Eligibility:**

- 1.1 The Program is open to legal residents of the United States of America who are currently enrolled as students at ACU Online.
- 1.2 The participant must be at least 18 years of age or have obtained the legal age of majority in their jurisdiction.

### **Scholarship Details:**

- 2.1 The Program offers a one time financial award of \$500 to eligible participants who refer a friend to apply and submit an application for review at ACU.
- 2.2 The referrer will be eligible to receive the scholarship in the term immediately following the referrals application submission.
- 2.3 The Program amount is subject to change and is at the sole discretion of the School.
- 2.4 The Program award is non-transferable and cannot be exchanged for cash or any other form of compensation.

### **Referral Process:**

- 3.1 To participate in the Program, the participant must refer a friend who meets the eligibility criteria mentioned in section 1.
- 3.2 The referral must be submitted through the designated referral form on the School's website labeled "Refer-A-Wildcat."
- 3.3 Friends submitted via Refer A-Wildcat who have already been contacted by the School will not be counted as a referral and participants are not eligible to earn a reward.
- 3.4 The participant must provide accurate and complete information about themselves and their referred friend.
- 3.5 Multiple referrals from the same participant are allowed, but only one Refer-a-Wildcat scholarship may be awarded each part of term.
- 3.6 The School reserves the right to verify the authenticity of the referrals and disqualify any fraudulent or dishonest referrals.

### **Privacy and Data Protection:**

6.1 By participating in the Program, the participant agrees to the the School's Privacy Policy and grants permission to the School to collect, process, and store their personal information for the purposes of the Program.

6.2 The participant's personal information will only be used in accordance with applicable data protection laws and regulations.

6.3 By submitting the email address(es) of your Friend(s), you represent that each Friend has given their prior consent to receive such messages. If you do not comply with the law, including anti-spam laws, you are obligated to indemnify ACU against any liabilities, costs and expenses it incurs as a result of such spam.

6.4 Your participation in the Program or acceptance of a scholarship constitutes permission for ACU to use your first and last name, and city and state address for any and all promotional or advertising purposes in connection with the Program, on a worldwide basis and in all forms of media without review, permission or further compensation of any amount or kind whatsoever, where permitted by law.

**Modification and Termination:**

7.1 The School reserves the right to modify, suspend, or terminate the Program at any time without prior notice.

7.2 The School reserves the right to amend these terms and conditions at any time, and any such amendments will be effective immediately upon posting on the School website.

**Governing Law:**

8.1 These terms and conditions shall be governed by and construed in accordance with the laws of the United States of America.

8.2 Any disputes arising out of or in connection with the Scholarship shall be subject to the exclusive jurisdiction of the courts of the United States of America.
