# **Admission Requirements:**


- Submit official high school and/or college transcripts.

# Bachelor of Science in Criminal Justice Major Requirements:



**CRMO 205: Introduction to Criminal Justice** An introduction to the concepts of criminal justice, the criminal justice system, deviance, crime, social control, law, justice, and constitutionalism, including the roles of the police, the courts, and corrections in the context

of the American system of criminal justice.

**CRMO 250: Police Systems and Practices** Introduction to the philosophy and history of law enforcement; US Constitutional limitations imposed on law enforcement in a democratic society; agencies within and levels of American policing and their functions; role and place of law enforcement in the total justice process; and current issues in policing.

**CRMO 320: Criminal Law** The study of general criminal law and concepts from the Model Penal Code developed by the American Law Institute, and the role of court decisions.

**CRMO 330: Domestic Violence** Examination of legal remedies for victims of intimate partner/domestic violence, including laws in the Penal Code, Code of Criminal Procedure, Family Code, Occupations Code, Insurance Code, U.S. Code, and Rules of Evidence.

**CRMO 365: Search and Seizure** Study or arrest, search, and seizure law with practical applications for criminal justice professionals.

**CRMO 420: Law Enforcement Leadership** Study of leadership theories in policing, including case studies of senior leaders in the field.

**CRMO 430: Evidence and Procedure** Evidence and procedure in U.S. legal system, including understanding of the court system and law enforcement functions.

**CRMO 455:** Professionalism and Ethics in Criminal Justice Exploration of theories supporting ethical models and analyses and how they impact decision-making in a criminal justice profession. Emphasis on the application of professionalism and ethical assessments for faith-based decision-making.

**CRMO 499: Criminal Justice Capstone** This course is designed to introduce students to career opportunities in the criminal justice system. It will provide students with experiences and skills to improve their employment opportunities after graduation such as shadowing, interviews, resume building, or an internship in appropriate situations. Available for variable credit.

### Supplement for the Major Requirements (15 hours)

(GVTO 225, GVTO 384, and PLSO 315 are required. Students are then required to choose 3 additional courses from the Political Science, Sociology and Criminal Justice sections).

GVTO 225: National Government The American political system.

**GVTO 384: American Judicial Process** Explores the structure and function of the judicial branch of government as it exists in our

### society today.

**GVTO 315: Political Science and Criminal Justice Research Methods** Theories, methods and statistical analyses used in political science and criminal justice will be evaluated, compared and critiqued. Students will gain an appreciation of research design, statistical analysis, and the application of these principles.

### POLITICAL SCIENCE

**GVTO 432: Constitutional Law: Civil Rights** Examines the civil rights and civil liberties of individuals in the United States. Topic areas include free speech, criminal procedures, cruel and unusual punishment, privacy, and equal protection issues.

**GVTO 487: Terrorism Studies** Examines and critiques the major themes of the field of Terrorism Studies. Will seek to answer: how do liberal democracies resolve political violence without betraying the rights and liberties of their citizens?

### SOCIOLOGY

**SOCI 388: Crime and Delinquency** An overview of the extent, trend, and types of criminal and delinquent behavior as well as research findings and theories associated with it.

**CRMO 355: Social Deviance** A theoretical and descriptive analysis of socially deviant behavior and the social interactive process in its definition and control.

### **CRIMINAL JUSTICE**

**CRMO 350: Corrections: Prison, Probation, and Parole** Study of the goals of the American correctional system and the roles of courts, prosecutors, pretrial officers, correctional officers, probation officers, parole officers, and re-entry specialists. Provides a practical understanding of the First, Fourth, Fifth, Sixth, Eighth, and Fourteenth Amendments as related to correctional issues.

**CRMO 370: Forensic Evidence** Forensic Evidence introduces the student to the history, theory, principles and practices of forensic science as it relates to the collection and analysis of evidence in criminal investigations. Students will gain a basic understanding of the scientific and analytical approach to determining the value of evidence as it relates to the court of law. Topics include crime scene investigation, trace evidence, fingerprints, firearms examination, DNA and bloodstain pattern analysis.

### **GENERAL EDUCATION/UNIVERSITY REQUIREMENTS**
