# Refer-A-Wildcat Program Terms and Conditions

The following terms and conditions outline the rules and regulations for the Refer-A-Wildcat program (referred to as "the Program") offered by Abilene Christian University (referred to as "the School"). By participating in the Program, you agree to comply with these terms and conditions.

# **Eligibility:**

- 1.1 The Program is open to legal residents of the United States of America who are currently enrolled as students at ACU Online.
- 1.2 The participant must be at least 18 years of age or have obtained the legal age of majority in their jurisdiction.

# **Scholarship Details:**

- 2.1 The Program offers a one-time financial award of \$500 to eligible participants who refer an individual to apply and submit an application for review at ACU, or refer a business that begins a corporate partnership with ACU.
- 2.2 The referrer will be eligible to receive the scholarship in the term immediately following the referred individual's application submission or the establishment of a business partnership.
- 2.3 The Program amount is subject to change and is at the sole discretion of the School.
- 2.4 The Program award is non-transferable and cannot be exchanged for cash or any other form of compensation.

#### **Referral Process:**

- 3.1 To participate in the Program, the participant must refer an individual who meets the eligibility criteria mentioned in section 1 or refer a business interested in establishing a corporate partnership with ACU.
- 3.2 The referral must be submitted through the designated referral form on the School's website labeled "Refer-A-Wildcat."
- 3.3 Individuals or businesses submitted via Refer-A-Wildcat who have already been contacted by the School will not be counted as a referral, and participants are not eligible to earn a reward for such referrals.
- 3.4 The participant must provide accurate and complete information about themselves and their referred individual or business.
- 3.5 Multiple referrals from the same participant are allowed, but only one Refer-A-Wildcat scholarship may be awarded each part of term.
- 3.6 The School reserves the right to verify the authenticity of the referrals and disqualify any fraudulent or dishonest referrals.

## **Privacy and Data Protection:**

- 6.1 By participating in the Program, the participant agrees to the School's Privacy Policy and grants permission to the School to collect, process, and store their personal information for the purposes of the Program.
- 6.2 The participant's personal information will only be used in accordance with applicable data protection laws and regulations.
- 6.3 By submitting the email address(es) of your referred individual(s) or business contact(s), you represent that each has given their prior consent to receive such messages. If you do not comply with the law, including anti-spam laws, you are obligated to indemnify ACU against any liabilities, costs, and expenses it incurs as a result of such spam.
- 6.4 Your participation in the Program or acceptance of a scholarship constitutes permission for ACU to use your first and last name, and city and state address for any and all promotional or advertising purposes in connection with the Program, on a worldwide basis and in all forms of media without review, permission, or further compensation of any amount or kind whatsoever, where permitted by law.

#### **Modification and Termination:**

- 7.1 The School reserves the right to modify, suspend, or terminate the Program at any time without prior notice.
- 7.2 The School reserves the right to amend these terms and conditions at any time, and any such amendments will be effective immediately upon posting on the School website.

## **Governing Law:**

- 8.1 These terms and conditions shall be governed by and construed in accordance with the laws of the United States of America.
- 8.2 Any disputes arising out of or in connection with the Program shall be subject to the exclusive jurisdiction of the courts of the United States of America.
